While such an event might include plenary presentations on general education requirements, using degree evaluation software, etc., the main focus would be smaller group discussions sharing advising experiences and practices, facilitated by members or former members of the CAA.
 - b. One-hour workshops available to individual departments focused on eliciting discussion of experiences and practices within a department. A faculty facilitator from the current or former membership of the CAA could be accompanied by someone from the Registrar's office or one of the advising centers to answer practical questions as they arise (not necessarily to offer a formal presentation that would cut into discussion time).
